## Helen Keller awards for firms, differently-abled achievers

NCPEDP felicitates those who set an example for others

The National Centre for Promotion of Employment for Disabled People (NCPEDP) in collaboration with Mindtree announced the winners of the eighteenth edition of the Helen Keller Awards here on Saturday.

The annual awards honour the differently-abled individuals who have overcome their disability and set an example for others from the community. The awards also recognise individuals and corporates working to ensure equality of opportunity in terms of employment and workplace rights, for the differently abled.

## Eighteenth edition

Javed Abidi, Director of NCPEDP said, "We launched these awards in 1999, when the discourse on employment for people with disabilities was unable to move beyond basket weaving and candle making. Today, when I look back, it is with a great sense of satisfaction. It is not about the gold medals or the number of awards but about the kind of examples we set."
