Tribunal has also directed that in case Respondents failed to make payment to the Claimant within one month as detailed above, it shall pay additional interest to the Claimant @11% p.a. on the aforementioned composite amount i.e. principal and interest.	The Fleur Hotels Limited ("Claimant"), a material subsidiary of the Company has filed an application under Sec 9 Arbitration and Conciliation Act, 1996 before the Hon'ble High Court of Delhi, seeking interim measures against M/s Hind Inns & Hotels Ltd. (the "HIHL") & M/s Hind Motors (Collectively, "Respondents").
