Biratnagar is a metropolitan city in Province 1 in Nepal. Its strategic location serves as an entry point to eastern Nepal as well as north-eastern India. Considered to be the industrial capital of Nepal, the city is home to the Biratnagar Jute Mills, the country's first large-scale industry, as well as the birthplace of five prime ministers of Nepal.

Located in the capital city of Province No. 1, this premier property will feature 80 well-appointed rooms and suites, complemented by a multi-cuisine restaurant, a bar, and a specialty pan-Asian restaurant. It will also have meeting and event spaces, and premium recreational facilities, including a spa, swimming pool and fitness center.
