This is in continuation to our intimation dated 15.12.2023 wherein Company had notified the Stock Exchange about the detailed Order dated December 14, 2023 ("Order") passed by the Hon'ble National Company Law Tribunal, New Delhi bench ("Tribunal") sanctioning the Scheme between the Transferor Companies and the Transferee Company and their respective shareholders and creditors for the amalgamation of the Transferor Companies with and into the Transferee Company.

In furtherance to the above, we hereby inform that the Scheme between the Transferor Company and the Transferee Company and their respective shareholders and creditors for the amalgamation of the Transferor Companies with and into the Transferee Company, has become effective (with effect from the Appointed Date of April 01, 2022) upon completion of the filing of the certified copy of the Order passed by the Tribunal sanctioning the Scheme in Form INC-28 with the Registrar of Companies, NCT of Delhi (MCA website) on January 19, 2024. Accordingly, the Transferor Companies stands amalgamated with and into the Transferee Company, in accordance with the provisions of the Scheme.

## <u>Further the said Form INC-28 filed by the Transferee Company dated 19.01.2024 has been approved by the Registrar of Companies, NCT of Delhi on 08.02.2024</u>

In view of the aforesaid and by virtue of the provisions of the Scheme, inter alia the following outcomes arise:

Consequent to the effectiveness of the Scheme and in terms of the Scheme, the authorised share capital of the Transferor Companies get merged to form new Authorised Share Capital of the Transferee Company and thereafter, the Authorised Share Capital of the Transferee Company shall stand increased to that extent without any further act, deed and without payment of any fees or charges or stamp duty to the registrar of companies.
